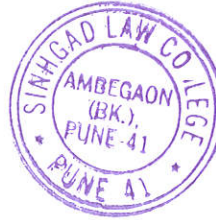

11. IQAC coordinator tendered vote of thanks and meeting was over.

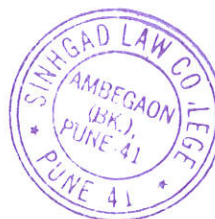

11. IQAC coordinator tendered vote of thanks and meeting was over.

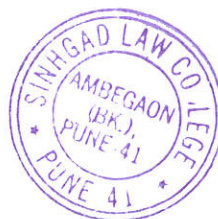
