- 10) Outcome- The officers explained how EPFO's objectives and functions are focused on providing social security for employees. The students took the brief information about various departments of the office.

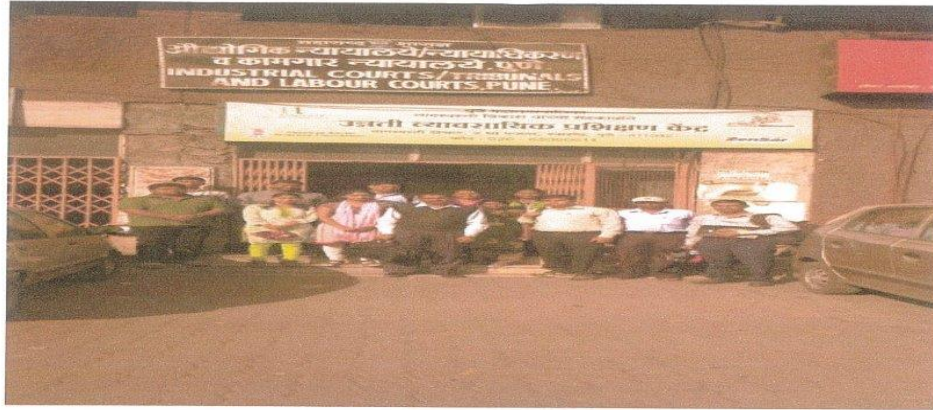
