5. Depth of coverage of the subject matter including reference to latest developments in the concerned area - 50 marks
6. Adherence to time limit - 10 marks Total - 100 marks

C) ELOCUTION COMPETITION RULES:

- Depending on the College, the language will be decided – either English, Hindi or Marathi
- Candidates will be given time slots to finish the elocution in that duration
