About the Legal Aid Committee-The Legal Aid Committee, is one among the other committees, which caters to the all-round requirements of its students. The committee acts as an instrument in ensuring that the social objectives and aims of the institution are pursued and achieved. Objectives- Legal Aid Clinics aim at two objectives. One is to improve the clinical legal skills of the students and the second is to inculcate an attitude amongst the students to provide effective legal services to the poor and marginalized people.

The Legal Aid and Awareness Committee of Sinhgad Law College aims at developing legal literacy among the rural population. The committee in association with District Legal Services Authority Pune organizes Legal Awareness Programs to disseminate legal knowledge to all citizens in general and to the weaker sections of the society in particular

The Legal Aid Committee and Vighnharta foundation and sinhgad student council conducted its second legal aid camp for the academic year 2017-2018 at Nangaon village situated in Tahsil Daund District Pune. The Legal Aid camp was conducted for a period of 4 day for the fourth year second year and final year students. This camp was orgnised on 10 March 2018 at 5.30 p.m. The Committee is constituted afresh every academic year, with the appointment of faculties/faculty in-charge to oversee the activities of the committee.

The committee constituted for the Academic year 2017-2018 was headed by Asst.Prof.Nitin Bhandare and Asst.Prof.Manjusha Mudgalkar as the Faculty Coordinators and Mr.Ajinkya Shedge, Mr. Nikhil Sharma, Mr. Vishwajeet kamble as the Student Conveners. It consisted of 23 members who actively participated in the numerous programs organized by the committee.

Rally and Questionnaire collection drive

In order to draw the attention of the villagers to the legal aid and awareness program, a rally was organised by the committee on 6th March 2018 in the same village wherein slogans related to sociolegal issues were raised and pamphlets were distributed to put forward the programmes that would be conducted by the committee in order to enable the villagers to know about the laws and policies.

7/30 000

The highlight of the 2nd legal aid camp was the village-wide survey that was undertaken by the students. The students were divided into groups along with a committee member and were briefed about the same. The students covered around 200 houses in the village and collected important data about the legal problems those are faced by villagers. One of the main aims of the survey was to know about the existing legal knowledge the villagers possessed and to Legal Aid Committee 2018-19 make them aware about the various other concepts of law. In addition to this, persisting problems related to transport, water, drainage health care were noted. The students then had to differentiate

between the houses that were eligible for legal aid and the houses that required legal aid.

It was found through the survey that the village as a whole doesen't has basic understanding of their rights in various positions. The villagers are not aware of legal concepts such as property rights of women, right to education, consumer protection and human trafficking. However, they are also not aware of government schemes, the law on right to information, free legal aid, lok adalat and mediation. The area has seen the light of the swacch bharath abhiyan but not in its entirety. A considerable number of women remained ignorant of many societal realities in totality.

OFFICIAL PROGRAM-

On the final day of the camp, an official program was held Legal Aid Committee 2017-18 by the committee wherein legal luminaries were called to address the villagers and the students. The chief guests for the day were: Advocate Laxman Ghule Secretary Pune Bar Association. Advocate Satyajeet Lonakar Senior Advocate Pune Bar. Advocate Lad. The Sarpanch Mr. C.B. Khaldakar and deputy sarpancha Archna Raskar Ex-Sarpanch Mr. Vishwas Bhosle and other dignitaries inaugurated the camp. Sarpanch felicitated all the dignitaries. Principal Dr. Chettiar and the Coordinator Prof. Nitin Bhandare and Prof. Manjusha Mudgalkar were present. The function started with lighting of lamp. Prof. Nitin gave a welcome speech. Advocate Ghule emphasized on the importance of free legal aid. Advocate Lad spoke about the importance of Land Law and advised the audience to take out 7/12 extracts and title documents of the house and land. Sri. Ashutrakar, Member Secretary, DLSA, Pune court spoke about the significance of free legal aid and asked the people in need of legal aid to visit the District Legal Services Authority. The program provided an open platform to the villagers who were eligible and in need of legal aid to put forward their grievances before the Chief guest.

Outcome-1) The student understood that focus of legal aid is on distributive justice, effective implementation of welfare benefits and elimination of social structure discrimination against the poor.

 Students also understood the practical applicability Article 39 A of the Indian Constitution and it states about providing free legal aid in order to ensure social welfare and bring in awareness about rights.


