**Pre Visit of Legal Aid Camp on 6<sup>th</sup> March 2109**


To provide free and competent legal services to weaker sections of the society so that they do not remain deprived of justice due to economic or other disabilities. Legal Services Camps primarily with an aim to provide legal services to weaker and marginalized sections of the society.

- 1.To spread awareness about welfare legislations and schemes, and strengthen the community's access to the schemes being implemented by the Legal Services Authority and other departments of government.
2. Identifying and connecting people to welfare schemes to ensure that fruits of welfare schemes are passed to eligible people.
- 3.To understand legal needs of people and address legal problems of people by giving appropriate legal advice and taking other necessary steps.

A team has visited Salavade Village for pre-visit to collect the grievances from village by taking 25 students with two faculties with well prepared questionnaire on 6<sup>th</sup> March 2019. The pre visit team reached the village around 10 a.m. Students were distributed in two in each spread over three villages to collect the data by visiting each house. In this visit the team was able to track the families with grievances related to land, accident domestic and marital issues.

These issues would address on the day of Camp by the Advocates after the Inauguration. People who were not given the grievance will be allowed to put up on the day of main camp.

Access to justice is essential for rule of law. Access to justice, enable citizens to have their voices heard, exercise their rights and challenge discrimination. Access to Justice is not confined to court based legal services. It extends to making people aware about their entitlements under various enactments and welfare schemes and programmes and strengthening their access to the same. 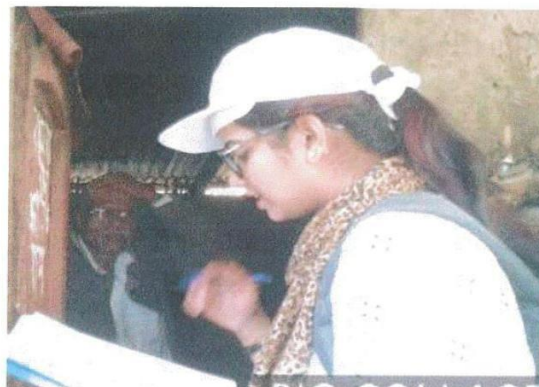
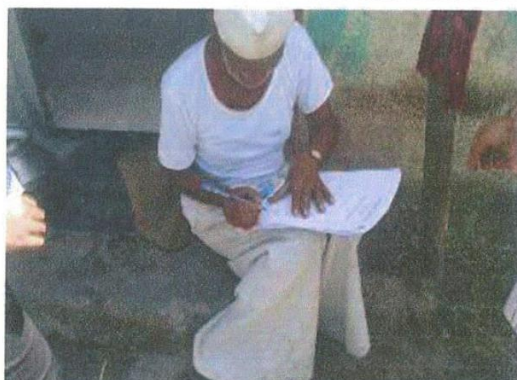

## SOCIO ECONOMIC SURVEY ON 6<sup>TH</sup> MARCH 2019

Socio Economic Survey was conducted on Saturday 6<sup>th</sup> March 2019 at Salawade Village Bhor Taluk, Pune District. The main objective of the village survey was to give students a practical knowledge of surveying and data collection. The village was a good example to understand the Socio economic status and changes happened in recent times.

It was observed from the collected survey the increasing level of education and school enrolment in case of females, increasing share of household members as well as household income in nonfarm activities, occupational diversification and increasing integration with the urban areas are some of the important changes that have taken place at the household level over the years. The analysis however also reveals economically vulnerable position of marginal, landless, scheduled caste as well as Muslim households as compared to other household categories.

Sinhgad Law college in collaboration with Savitribai Phule Pune University's Bahishal Shikshan Mandal and Senior Citizen Helping Center conducted a seminar on the topic 'Role Of Government regarding senior citizen'.

The chief guest Mr. Arun Rode, President of FESCOM, senior citizen union graced the occasion with his valuable presence. Sir focused and explained the role of government and the need for the policy formation for the betterment of the senior citizens as they constitute the weaker sections of the society and are unable to maintain themselves. He expressed his concern about the neglectment of the issues of the senior citizen in the country. As the worldwide population of senior citizen consists of 10% to 12% they should be given utmost care.

Sir gave the estimation that there are one crore thirty six lakh senior citizens residing in India and there is an increase in the birth ratio than the death ratio. Sir stressed and stated that for the first time the United Nations Organization have thought that 1<sup>st</sup> of October is to be celebrated as the Senior Citizen's Day, to have the main focus on senior citizens and spread the awareness about the problems and concerns of the senior citizens.

For the first time Honorable Prime Minister Atal Bihari Vajpayee on 25<sup>th</sup> of October 1995 passed the bill for senior citizens, but Rode sir stated that the state government and the central government neglected the concern in the past and it is neglecting it today. Only 8 states in India have passed the bill and adopted the policies. On 4<sup>th</sup> June 2004, Maharashtra government accepted the policies about the senior citizens but did not provide any funds for the same and promoted Non-





Rode sir who is the president of the FESCOM (Senior Citizen Union) provided all the statistics and expenditures related to the senior citizens to the government but the government has always turned a deaf ear to these issues, because only 9 percent of senior citizens are benefitted from the pension plans the rest are needed to be protected. In the term period of honorable chief minister of Maharashtra Prithviraj Chauhan presented the bill for the senior citizens but no funds were provided.

United Nations stated that people who have attained the age of 60 years shall be declared as the senior citizen, but in Maharashtra as per the bill passed the seniority age for male and female is 65 years of age and then the status of the senior citizen would be granted to them. On 30<sup>th</sup> of June 2013, Honorable Prime minister Prithviraj Chauhan considered that the seniority age to be raised to 60 years, but raising the age to 65 years created the issue for benefitting the schemes to implement by the government, but then FESCOM continuous recommendations the age was finally lowered to 60 years. In spite of this the demands placed before the central government and state government are not yet fulfilled.

The following were the demands-

- 1) The reservation to be granted by the state transport who are of age 60 years rather than 65 years and 50 % exemption to be given.
- 2) The cut - off of the below poverty line people should be more than 21000 rupees.
- 3) Each senior citizen to be given a grant of rupees 3000 every month.

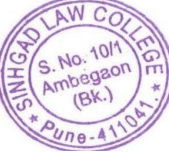

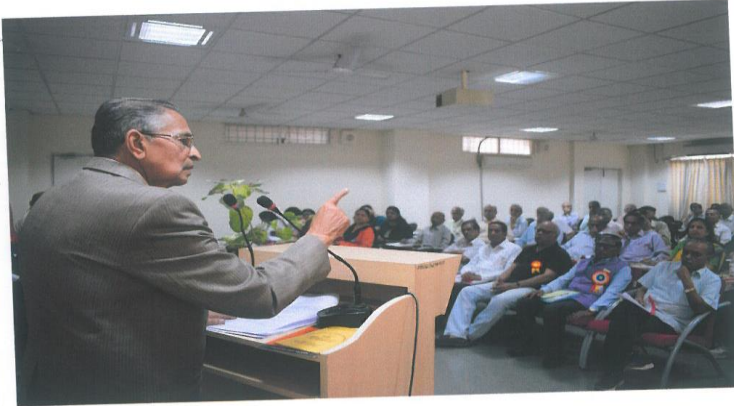

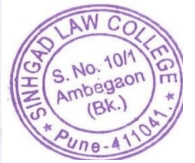
