Further the students were fortunate enough to interact and understand about the practical provision and functioning of registration process to enroll and become a practicing advocate by Adv. Pravin Ranpise Secretary Bar Council of Maharashtra and Goa. Also, the students were privileged to meet and interact with advocate sandip Babar, who explained and made the students understand the technical and functioning aspect of the Writ Cell of the High Court.

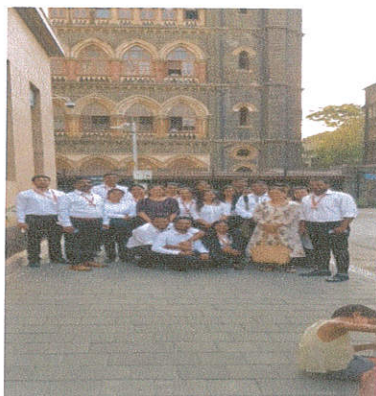

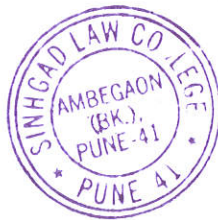

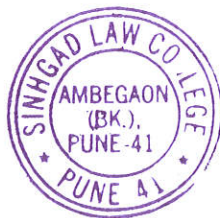
