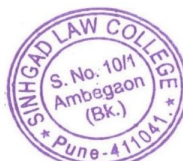

Object of the Event: - The Guest Lecture aimed to highlight the benefits and advantages of choosing civil services examination as a career option and the best strategy to succeed.

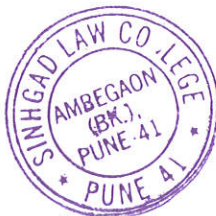
• EVENT DESCRIPTION
