### REPORT OF COMPETITIVE EXAMINATION CELL ACTIVITIES

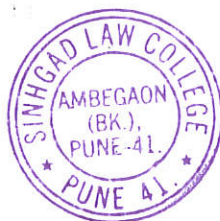

The valuable guidance given by the guests proved indeed very informative and helpful for the students.



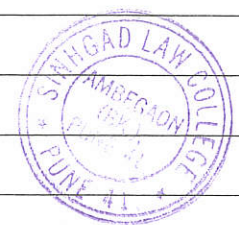
