



COVID 19 VOLUNTEERING BY MAITRI MEMBERS & STAFF FROM 11th MAY TO 21st MAY

All the residents were very cooperative and did not hesitate to give us their data. After 7 days of quarantine, we did a swab test and tested negative. We were allowed to go back home after the test. **4 Students were present.**
