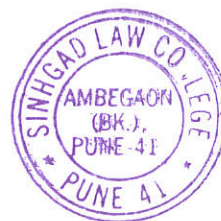

Object of the Event

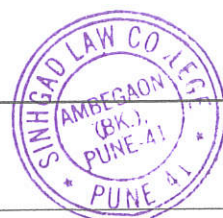
- 1) To reunite the old and new students on one platform.

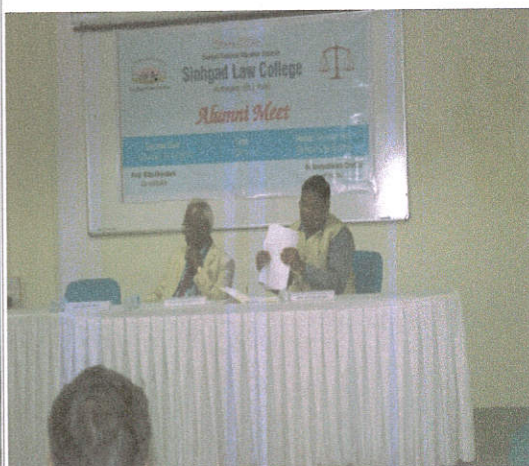

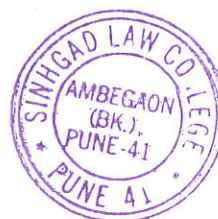

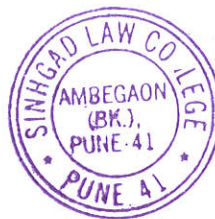

Object of the Event; -1) To create awareness about Moot Court and Trial Advocacy Practice among the students.

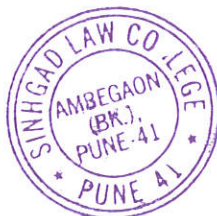
2)To prepare the students for the complexities of oral advocacy and articulated research.

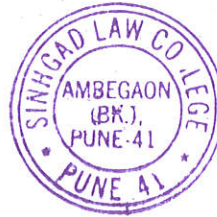

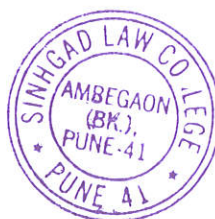
