It was towards the end of the last century that medical ethics assumed the character of a distinct discipline in India, attracting the attention of professionals from both law and medicine. However, bioethics was not a major issue in professional discourse at that time. The focus was more on technological applications in medicine and healthcare and their human rights implications. The concern was on medical negligence and the need for consumer protection.

Within two decades, the nature of the discourse changed considerably because of the progress in biomedical research and applications, including genetic engineering, assisted reproductive technologies and human cloning. The advent of biotechnology in a big way transformed Indian medical research, promising hitherto undreamt benefits to humankind. Legal regulatory systems were soon found to be inadequate to achieve the desirable balance between research procedures on the one hand and ethical standards on the other.
