





Sir explained what are Geographical Indications and told the examples of GI registered by him e.g. Mahabaleshwar Strawberry, Darjeeling Tea, Scotch Whisky etc. After that sir explained some provisions of the Geographical Indication of Goods (Registration and Protection) Act, 1999 and how GI is protected for products like Agriculture, Natural, and Manufactured Goods which comes under this Act.

Then sir explained the examples of GI on the base of case study e.g. Agriculture Goods Mahabaleshwar Strawberry, Manufactured Goods FENI, Natural Goods Makrana Marble etc. He explained the Status of GIs in India and in India 370 GIs is registered. Then what problems comes under Geographical Indication, what is current senior of the GIs, what should be done for protecting more and more original GIs,


